Hank Carson, WDFW

Hank was presented, along with Josh Bouma from PSRF, seeking public input on a proposed State listing of 'endangered' for the pinto abalone. Hank's in-depth presentation included history of the recreational & sport fisheries, current population status, recovery efforts, and the status review process closing at the end of March 2019. A report and instructions for public comment are available at wdfw.wa.gov/conservation/pinto abalone.

Josh Bouma reviewed the past decade of abalone recovery work: hatchery at the Kenneth Chew Shellfish Center near Bremerton, recruitment sites in Skagit and San Juan Counties. Idea for growth: satellite 'grow-out' operation at Friday Harbor Labs.

Discussion:

- These efforts have been partly funded by the State, some money from Skagit MRC
- For fundraising, contact Jodie Toft at PSRF, facility tours are also possible
- This is a powerful local issue because of abalone habitat largely within San Juan County

Marta Green

- The oil spill consequence assessment to SJC and emergency response towing vessel (rescue tug) cost evaluation has been completed. A summary factsheet was distributed that includes the economic consequence numbers and a figure showing a model of the trajectory of oiling. This is a cost/benefit model that conservatively estimates economic damages to warrant the establishment and maintenance of an Emergency Response Towing Vessel (ERTV) stationed in the San Juan Islands.
- House Bill 1578 had language that enabled Ecology to conduct a rulemaking that
  would require vessels calling on WA ports to fund an ERTV stationed in the San
  Juan Islands. This language was stripped from the Bill just before the House floor
  vote (update provided by Lovel Pratt). Thus we need to make a better case.
- Needed now: ideas on venues/audiences/opportunities for broader communication

Eelgrass restoration (SJI Conservation district), oyster breakwaters (KWIAHT), Crescent Beach restoration (SJ County), Griffin Bay protection (FoSJ), and Salmon Point restoration (FoSJ).

MRC will be involved again for site visits and expected to attend presentations (first week of May), encouraged to attend site visits. Proposals will be distributed to this committee prior to site visits in May

Salmon Recovery Council update:

Chapter update is on Byron's work plan, Terry and Karin are involved, they have yet to meet, Sam will be in charge. There is a Salmon Recovery conference April 8-9<sup>th</sup>, in Tacoma

NW Straits Partnership updates:

- Seeking a new executive director, prospective replacement has applied. The Governor will appoint this position. MRC can express support to the Governor's office.

Marcus Reaves introduces himself, new habitat biologist, based in La Conner

Brendan Cowan, Jen Olson

Brendan Cowan: County emergency management director, get islands ready for out-of-the-ordinary events including oil spills. Jen Olson: whale museum marine mammal stranding network, experience with emergency response to wildlife issues, IOSA volunteer since 2014.

IOSA is a group of volunteers ready to respond to marine oil spills, first on the scene for any complaint of sheen or sign of oil. Last year IOSA BOD put a pause on operations, now trying to reinvigorate IOSA. Implementing structure with accountability - 'incident command system'. Presented to County Council Dec 10, 2018, first met on Jan 19, 2019, now meeting monthly. Accomplishments: we've set up trainings, scheduled public outreach meetings, hazardous materials training in May here and on Orcas. By October primary response contractor (prc) status with Dept of Ecology, Initiate hiring for 2 staff members by November -99.9% of IOSA's hundreds of responses over past 30 years are small but add up to tens of 1000's of gallons. Local response is the core of what IOSA does and it's important -the key to IOSA's long-term sustainability is multi-tiered approach, local and regional - the most critical thing IOSA is going to do in a big spill is Protect wildlife and deploy booms, plug into larger response (know where equipment is, who's available, etc.)
Historically IOSA funding has come from the industry. Need funding from local government as well. There's a vision for IOSA to be a professionally equipped and managed, budget by 2020 based on donations, local SJC government, and industry.

JEN: wildlife is important here, 200+ spp. of birds and mammals. Wildlife ops are logistically challenged and highly regulated. Now IOSA isn't equipped for permitting for all types of

wildlife rehab but do have extensive volunteer network. Potential partnership with Focus Wildlife based in Anacortes, an international response facility with many resources. We have the staff to command, critical knowledge and they can provide training and oversight of ops.

### Discussion:

Q: who's responding now? If there were an incident now that IOSA responded to in the past? Brendan: now resources are further away. Ecology or Coast Guard would need to bring in a contractor to set up booms, coming from the mainland within 4-5 hours instead of 1-2. This isn't about the super-tanker, this is about local small boater. Now there's no local response Q: does IOSA take any advocacy or prevention?

Brendan: can promote good practices around marinas, refueling. IOSA is a response org, not overlapping with other missions. Want to keep relationships with refineries/shipping.

Q: what's the point of meetings – to get more volunteers?

A: yes – there are different levels of volunteers: Initial response team need to be physically fit, good boat operators, committed to training. Then others who commit to an annual 8 hour training, help with logistics, shoreline training, participate in exercises twice a year. Also people who aren't trained at all but willing to support, feed & house & drive volunteers around. Need to rejuvenate volunteer core and keep database of potential volunteers.

Q: what would be response time to a spill from a large tanker?

A: Depends where it's coming from. Variables that impact the outcome of a spill include response time, but also weather, currents, etc. Prevention is definitely the foundation.

Q: Is there an expectation of County funding for an independent nonprofit?

Brendan: IOSA is a 501c4. Brendan has Council's support to work on this as part of job but also volunteering his own time. County leadership has decided to support this separate org during this rebuilding phase. In the long term, more independence with county involvement. Kendra: we have the derelict vessel program under solid waste, that has some funding but the county general fund pays a lot to deal with sinking boats.

Brendan: we're trying to keep IOSA to response, the prevention piece still needs work. Last summer DNR paid to haul away the derelict boat on Lopez, Mark Herrenkohl helped.

Q: Are there lessons about wildlife response learned from the BP oil spill?

Jen: from logistics side the entity responsible will pay for most response. Also experience with Exxon-Valdez. They did some research, capture studies, learned impacts on mammals. But those lessons would be applied differently here because we have different resources Brendan: can't apply those lessons unilaterally because weather, water temperature, distance to land, can all be different in Salish Sea when compared with those situations Marta: In a recent study about impacts for our County, we extrapolated data from 7 other major spills. That study resulted in a wide range of economic impacts.

A public presentation about those results will be here at the Grange, May 8<sup>th</sup> 11am-1pm Brendan: we'll know by May about some funding, we'd like to check back in with MRC in October/November to better inform about how we can support each other Some discussion of Emergency Response Tug Vessel research, availability and location.

- a) Whale Flag presented to the Whale Watch operators, sold 44 flags. The interim report is still in process, due to Marine mammal commission mid-May.
- b) Outreach and education: Anacortes Boat Show May 16-19, Taylor Shedd from Soundwatch will lead but need volunteers. Dock talks in June can happen on every island, this is education about "be whale wise", whale warning flags, and new regulations. Youth conservation core may help. We'll have a communications intern for the summer
- c) North of Falcon public meeting summary Karin Roemers-Kleven Giles, Cindy Hansen, and have attended as well as WDFW meetings advocating for whales. We're asking for salmon. Karin as a story-teller/naturalist, Cindy from Orca network provided data. Giles, as a scientist, and also representing Friends of the San Juans, provided studies describing the importance of whales to the ecosystem. Made some productive connections with fishermen.

North of Falcon involves Canada/Alaska/WA, tribal leaders and other entities looking at numbers of fish returned in 2018, which should inform which fish are available. Chinook salmon and some chum runs are seriously depleted. Coho and sockeye seem ok. Managers are mostly looking at returning numbers, not considering climate change.

Overall positive response from WDFW and productive meeting. Brendan Flynn is part of the task force as a fisherman.

Q: could we have a transcript of the three viewpoints from your talking points at these meetings, the story teller, the orca network and the scientist.

The SJ museum of art is doing an exhibit this summer about whales called "deep dive", June 15-September 15. A symposium in the theater next door on July 13, Jean Michel Cousteau and Alexandra Morton slated to be speakers, maybe Ernest Brooks (artist & conservationist)

Christina: the Navy has released its draft Environmental Impact statement for review, comments being accepted until May 28. More growler training would mean more noise. The vessel working group will meet to discuss this soon - Rec 25, coordinate with the Navy in 2019 to reduce noise, is a year 2 recommendation. Frankie will be part of that group.

ACTION ITEM for Kendra: follow up with Jamie to see if this issue is already on to-do list, if not let him know the MRC is in favor of less growler training

Q: is there evidence that growlers affect marine mammals?

Laura: yes, there were studies that came out of the SRKW workshop, Rob Williams. The gist is that sound from air can be perceived in the depths of water, in frequencies they can hear, but not yet clear what the impact is on behavior.

Sarah McCullugh: Lead naturalist and captain on SJ Safaris, background in wildlife management. Second time speaking in front of MRC. A 650 yd approach limit not supported by science, Holt acoustics study shows that speed is more important than distance. Emily Schaller: San Juan Safaris & San Juan Outfitters, involved in whale watch community. The ballot initiative is a waste of resources/time on an issue that has already been examined through the task force process. We are models of good behavior for private boaters, lead to conservation efforts and contribute to science by reporting observations on behavior.

Derelict Gear Removal in San Juan County Monica Shoemaker Presenting for Joan Drinkwin from Natural Resources Consultants (NRC). DNR has an Aquatic Restoration Program (bulkhead removal, removing marine debris like derelict floats etc.). Launched "MyCoast" app in 2018. Used to record debris observed on shorelines and report. Lost fishing gear (abandoned/ghost) is a global problem. Nets suspend in water column, drape on rocky reefs, continue to catch animals. In 2001 the NW straits initiative identified this as a priority, developed protocols/guidelines for removal. Since 2016 nearly 5,785 nets removed in shallow water habitats. Current loss of fishing nets is lower, 10-20 nets annually. In San Juan County 2,224 nets removed, almost 500K animals saved. Deep water nets: can't be accessed by most divers. Some experiments using ROV's to remove nets, somewhat successful but expensive. Introducing a new deep-water derelict net removal project, partnership with NRC and the Army 569th engineer Dive detachment out of Virginia, July 8-28 2019. Their program provides support and diving, WA DNR is funding, pick up & remove nets. Local vessel hired, the Sea Horse with onboard decompression chamber. Divers staying in FH. Focus on cluster of nets on west side of San Juan island on nets 130-160' deep. Working from south to north. All permits are in place. NRC will record what's removed.

Project will follow whale wise protocols, engines will be shut down while divers are down or if whales are present. Joan & Monica will present at Whale Museum series June 25<sup>th</sup>. Search 'DNR Deepwater Nets' for links to more information QUESTIONS:

Quick review of CAG scoring criteria. Establish that we have a quorum. Sam has some scores already (Kendra, Lovel, Phil, Ivan, Karin, Christina and Jeff D.). Megan, and Cathleen provide their scores. Laura Jo and Terry did not provide scores.

Conflict of interest assessment: Kendra has a conflict of interest on Crescent Beach project due to being a Public Works employee. Lovel has a conflict on the Salmon Point proposal due to being a FOSJ employee. Is Megan a conflict on the eelgrass project because of association with the Labs? No, no financial benefit to Labs only to a few individuals directly. CAG ranking came out with Salmon Point first, Griffin Bay & Eelgrass tied for second, Crescent Beach 4<sup>th</sup>, oyster project last.

### Discussion:

Question - Kendra: it's hard to separate CAG and TAG ranks, can we combine them?

A: no, ranking for two different purposes - scientific vs. socioeconomic (ie. Stakeholders, outreach)

Q-Kendra: but projects could be reviewed across the board, more efficiently, we're disadvantaged by not getting to hear what the TAG said. The process could be more transparent

Laura F: Island County have combined TAG & CAG, but it's a separate group from MRC

Phil: but here in SJC, the MRC is mandated to be the CAG. TAG is also set as a committee

Kendra: Council would be ok with combining, streamline and reduce committee fatigue.

Phil: I got out of the TAG because I didn't have the expertise to decide about restoration projects

Megan: if people who didn't know about salmon vote on benefit to salmon, that would bother me.

Kendra: there could be a provision for that in the spreadsheet, weight scores differently from technical experts, but meeting together would allow us to hear from everyone.

Ivan: you can combine the meetings without combining the committee

Next steps: we provide a ranked list by August 15, then SRFB review, then finalized Nov. 6 Budget: we have enough to fund top three (not Crescent Beach or oyster reef). We will get return funds but uncertain timeline. Friends' project increase request may need to come from return funds Laura F: next grant round will start sooner, pushing it up so it'll end around August of next year Sam: we need to submit a ranked list that's as close to the allocation amount as possible, if we exceed the amount we need to list the fourth project as an alternate. OR list all four but ask projects to reduce the amount they need. Important message for the future that grant rounds are tight Megan: if we cut 10% from all projects we could fund all four

Sam: since ranked list isn't due until August, we could go back to proposers to ask about reduced funding. If Preservation Trust and eelgrass projects reduce funding we could fund Crescent Beach

There are two options: fund top three with Crescent beach as an alternate OR go down the list and get project sponsors to reduce funding requests in a way that allows us to fund all four MOTION: Kendra moves to ask project sponsors (preservation trust, SJ public works, and conservation district) to look at budget request and ways to reduce funding so that all four projects can be funded Megan seconds. ## Status review of active projects

SRKW: Flag project: #flags, outreach effort, next steps:

- Interim report submitted to Marine Mammal Commission in March. More flags this year than last year, more requests coming in. One problem: Canadian DFO enforcement wanted a way to identify commercial whale watchers who have permission from DFO to allow them to approach transient killer whales to 200m instead of 400m within SRKW Critical Habitat in Southern BC. They ordered their own flags without consulting, so whale watchers here will need to fly both flags. Too late to rescind/change Be Whale Wise flags, they already have a lot of traction
- Action: Frances to discuss with Jeff F and Ivan.
- Westside marine spatial planning project update
   We're behind, delayed money from NFWF, needed stakeholders in the spring, then collecting data. Now instead we'll try to get data first
   Meanwhile: 30 Army divers, barge stationed on the outside corner of Eagle Cove. They started off edge of Salmon Bank, then around point. They got 4 nets so far, plenty more down there

### Plastic Free Salish Sea:

- Upcoming beach clean-ups with YCC (youth conservation corps.), late July (2 next week and 2 the following week). Kendra waiting to hear back from YCC. Stand by for requests to help

Bull kelp bulbs and blades have been used traditionally by Samish. Friends of the San Juans did a baseline map from aerial surveys in 2004-6. By 2016 aerial photography was more developed, worked to hand-digitize kelp map for the San Juans, created a chart map.

General findings: compare acreage between 2016 and 2006, over 30% loss kelp coverage in County. Next steps: continue ground-truthing by comparing substrate (using ROV) in sites where there was loss vs. gain. Working with NOAA and NW Straits to identify potential restoration sites.

9:15 AM Marine Debris Clean-up in Samish Traditional Territory *Todd Woodard* Creosote is a good wood preservative, also full of carcinogens. 5 years ago started working with WA DNR, Conservation Corps, Veterans' corps. Earth Corps. In 2017 started going to beaches, removing treated wood, Styrofoam, net pieces. We started a dataset to ID where there is most need. Surveys, walking beaches with GPS and cameras, that guides clean-up efforts for the following season. In 2017-8 we covered most of San Juan County. Map showing locations of most debris, mostly creosote pilings. Total amounts removed per island per year: bar graph shows weights per year per location 2017 – 160K lbs removed, 2018 – 122K removed, in 5 years over 750K lbs. removed from beaches. By next summer we'll top a million pounds just in San Juan County since 2014. Waste us taken to the Burlington transfer station, sealed land fill. The state is handling the disposal costs. The best way for citizens to identify waste ready for disposal is using the MyCoast app.

One site under discussion now is Sucia, in between two big islands in Echo Bay (also considering Deepwater Bay on Cypress but that's not in our County). Concept: full time employees, divers maintaining pens, etc. Maintenance, materials, many ways SJC would be affected \$50 million in start-up costs, \$2 million per year (Frankie thinks that's a vast under-estimate), all of that should be part of a feasibility study. They also need to do an Environmental Impact Statement, then get a permit. This group came to the Council, which isn't taking a position yet They have some big financial backers, but seems like it's still in a dream phase. Their tour was largely to introduce the ideas and get public feedback, next they can work on the proposal Timeline is to start permitting by end of 2019, have it by 2021. Have first whale by 2022 Consultations with experts suggest you can't do proper rehab in a net pen, need a controlled environment, even then can't always be released into the wild

Kendra: the County has a restriction on net-pens that may be a barrier, they should look at our code Lovel: the council should ask us to provide a recommendation or have it on our work plan for the MRC to review further and make a recommendation.

## 8:49 AM Forage Fish Spawning Surveys in the San Juans

Tina Whitman

This project targets sand lance. Forage fish play a key role in marine food webs. Three local species: pacific sand lance, surf smelt, and pacific herring. These fish spawn on shorelines at high tide. They have specific spawning sites. DFW developed a protocol, basic/low-cost. Collect sand on beach, use screens to look at material. Agitate sand and eggs to look at in microscope. Now a new method for the egg separation stage uses a vortex bowl to process, better for detecting sand lance eggs. Last winter we documented 5 new sites due to a combination of increased effort during that crucial winter season plus new better egg detection method. This 3-year project began last winter 2018/2019. It is tide and time limited, a site needs to be covered a few times a month and windows for sampling will be only an hour or a bit more. Cooperative projects going on with the Waldron and Decatur schools/communities. Some volunteers in Stuart. It's usually mostly November/December. Volunteers will complete training including purpose/background of project and practice in sampling methods. Samples are sent off for analysis by Dan Penttila. Data sheets must be submitted properly with date/site/etc. Samplers use phones to collect GPS points and photos.

There will also be trainings on Waldron (Thursday Nov 21<sup>st</sup>) and Decatur (weds, Nov 13<sup>th</sup>). One training for ferry-serviced Island on Saturday October 26<sup>th</sup>, 9am-1pm above FH fire station. ACTION ITEM: Tina will send out formal training invite through Frankie for broad distribution.

Proposed extension of Critical Habitat designation for SRKW & humpback whales, Public scoping on ways to reduce vessel impacts on killer whales

Three proposals: critical habitat for humpbacks, SRKW critical habitat revision, and vessel regulation public scoping comments. Lovel, Phil, Ivan, Frances were at recent Vessel Reg. Scoping meeting

## 1. Proposed Revision of critical habitat for Humpback Whales

Three distinct population segments of humpbacks: endangered western pacific, endangered Central American (< 800 whales total) and threatened Mexican (< 3000 whales total)

Main threats are ship strikes and entanglements (22 known last year = increase from previous years) Proposed areas for Mexican pop: Alaska, WA, OR, and CA; Central American pop: WA, OR, and CA. Includes waters on the US side of the Juan de Fuca Strait up to Port Angeles, not the Salish Sea *Ivan: we're seeing humpbacks regularly, almost daily.* 

Frances: It's prey-related. Recent symposium recording with talk about humpbacks available online

ACTION ITEM: Frankie will send a link to that recording

Q: is there any chance of getting the inland Salish Sea designated as part of the critical habitat? A: we can make that comment, but they're not designating now because there's not sufficient data. Lovel: comment that critical habitat expansion into inland sea should be considered for the future. Frances: comment period for humpbacks closes Jan 31<sup>st</sup>

ACTION ITEM: Frances will look for data on humpback ship strikes

Q: are BC pilots for shipping required to report whale ship strikes?

#### ACTION ITEM: Frankie will find out about that

The Navy proposes the Quinalt Range site off WA coast as an exclusion area, claim the proposed critical habitat would impact their ability to test equipment/systems and therefore national security. NOAA determined that would be appropriate

Ivan: humpbacks aren't using the entire Quinalt Range but they are traveling through it. As the MRC we don't need to consider the Navy's needs. We can comment that this area shouldn't be excluded. Currently Navy can't test explosives within 50 kn from shore but can use sonar within that range.

ACTION ITEM: Frankie will send around these slides

### 2. Proposed Revision of SRKW critical habitat

1. 'Summer core area' = Haro Strait and SJI, 2. Puget sound area, 3. Strait of Juan de Fuca area. Critical habitat requirements: water quality, prey, passage conditions allowing migration/foraging. Proposal for 6 new areas along WA, OR, & CA. Range 6.1m-200m depth contour NMFS is not proposing to include anthropogenic sound as a physical or biological feature. The Navy is requesting the Quinalt Range Site (QRS) + 10km buffer as exclusion from Critical Habitat. Q: Do river systems in the QRS supporting chinook/coho runs? Includes Hoh, Queets, and Quinalt Lovel: our comments should point to the potential presence of salmon in those rivers as whale prey Ivan: based on trends for SRKW for last few years on outer coast they could be anywhere in that range. In inland waters in 2017 J pod was only in Salish Sea (east of PA, south of Nanaimo) 88 days/24% of the year, K pod only 36 days, L pod only 47 days. In 2018: J 113 days, K 37 days, L 38 days. In 2019 (only through the end of October): J was here 81 days/26% of that period, K only 22 days/7% of the time period, L 20 days/6.6%. This critical habitat is way overdue and we should push the Navy on this exclusion zone. It cuts up the critical habitat making transit inaccessible Frankie: for the QRS, tagged whales mostly from K & L pods, mostly in Southern area. The area represents 16.4% of whales' winter range. Median time 13 hours with average 6 days between visits NOAA says insufficient analysis to determine whether Navy activities would adversely affect whales

MOTION: Lovel moves that Frankie draft a comment letter for the council to consider with regard to proposed critical habitat for SRKW. (And that humpback letter can be put off to right after the 1<sup>st</sup> of the year as to not confuse council. Deadline for SRKW comments is 12/18). Phil seconds, all approve. Marine Mammal Commission report due on 12/20

Previous MRC comments: Supported inclusion of SJI region in critical habitat for SRKW, recommended shallow nearshore waters be included, and that NOAA consider impacts of oil spill Q: Can we request that Council attach 2016 letter to this letter? Those are all good points

### 3. Reduce vessel impacts on SRKW

NOAA says impacts on finding prey and from vessel strikes are now well-studied. Scoping comment period deadline: December 23<sup>rd</sup> Lovel: one aim during this scoping period is to get some transboundary consistency in regulations Ivan: Canadian interim measures for 2019 expired at end of October, they're re-starting the process Lovel: There's value to improving whales' environment through mitigating vessel impacts
History: 2009 MRC approved 200 yd approach, 7 kn speed limit within 400 yards of whale waters.
There must be enforcement and education, NOAA to work closely with Soundwatch
MRC did not support the no-go zone as written because of community concerns

Jeff: traffic separation scheme info about specific locations (?)
ACTION ITEM: Jeff will send that data to Frankie

Frankie: the idea is that we come up with a suite of options for 'quiet zones' for SRKW to forage on the West side, and we present that to the Feds who have the authority to enforce it.

- We support uniform regulations. We encourage transboundary cooperation with consistent messaging. This group supports the effort to look at where foraging-based zones make sense

Conclusion to this discussion: Frankie will draft a letter including the following,

- 1. NFWF grant research that's underway
- 2. Continued education and outreach to boaters
- 3. Enforcement & following Washington state's lead with regard to boating regulations (and include comments from 2009)
