Adam: I need to leave early, I'd like to move the Jackson Beach discussion to the top of the agenda
No other changes, Adam moves to approve the agenda. All in favor.

Approve MRC April meeting minutes *MRC Members*

Sam received no edits. Sandy moves to approve, Dave seconds. Lovel abstains (as did not attend the meeting). All in favor, the April meeting minutes are approved.

9:04 AM • **Updates/Next Steps re: Jackson Beach** *Sam Whitridge*

Adam: we met at Jackson Beach, got clarification on the miscommunications that led to this situation. Restoration plans would result in losing 15' of the staging area on the beach, requiring more effort/cost for barges to reach shore. So, they developed a plan that would result in full functionality of the staging area instead of the approved restoration plan. Climate change/sea level rise/erosion were addressed. Kari McVeigh expressed interest in looking into long-term viable alternatives for the County. Studies would need to be done.

Kari M: we plan to meet with PSP and still hope to use the available funds for restoration

Tillery: we have short term solutions we need to address and more long-term planning that needs to take place

Sam: initial SRFB funding from 2024 funds were returned to the County to use for other projects

-Frankie provides information on how the mitigation calculator works

Brian: I still find it hard to believe we got this far without approval from the County

Adam: there was previous Council approval for this project and plans that were stamped by Public Works.

-MRC staff reviews the timeline of the design and approval of the project. PRISM link shared in last meeting. We also had an erosion analysis. The project was designed to move rock on the beach to build in future resilience.

Brian: still need to resolve this miscommunication before going forward with future projects

Colin: these plans impede PW operations. That has been my consistent feedback. Environmental Stewardship prepared the report that claimed these activities would be compatible at this site, PW never signed off on plans.

Lovel: This has been through multiple permit review and grant application processes that County approved. The applications have always acknowledged the barge landing site as well as all the recreational uses.

Kari M.: I was at the meeting Colin referred to along with Kendra, Jessica Hudson (County Manager); the activities didn't seem compatible. Colin said to Kendra, if you have a study that shows we can do both go for it. Kendra commissioned Facet for the study. Going forward we'll ensue PW and ES can be in full collaboration

Charles: For Kari M – you mentioned a next interaction with PSP. How do you see this moving forward?

Kari: I'm looking forward to more cooperation and meeting with Mindy at PSP

Tillery: there is some information that doesn't add up somewhere in terms of the communications issues. At some point it may be good to sit down. We're committed to a solution that fits both purposes.

9:31 AM **Northwest Straits Commission (NWSC) Updates**

Mike Ramsey

Presentation from DFW about the uses for kelp and human interactions with it; their website has more on kelp. Jamie Stephens was elected as Chair of the Commission. Planning molt surveys of invasive Green crabs, opportunities for surveys and outreach.

Question: are there local mitigation actions for Green crab?

Lovel: yes, talk to Jess Newley from Friends of San Juans, they have been conducting efforts

Mike: Science Advisory Committee welcomed Nicole Naar. Cecilia Gobin from NW Indian Fisheries Commission, have a new report out for 2026. And new funding opportunity - they want us to brainstorm what we'd do with \$500K per year, what would our priorities be - they want to have that cued up for May 29th commission meeting

Lovel: maybe we can schedule a separate meeting with whomever is interested to discuss it further?

Kari: if there no restrictions on funding, we can draw from our work plans

Olivia: any other written document we could look at describing the funding?

Charles: Should we emphasize projects or the strength of funding the ES program/staff in SJC more broadly?

Matt: we already have several subcommittees, let's get proposal to Mike to present at this meeting

ACTION: form a subgroup and meet in next week or two. Christian, Lovel, Olivia, Mike. Sam will take lead

9:54 AM **2026 Annual Review of San Juan County Commercial Shellfish Growing**

Jessica Nye

Jessica Nye, Diseases prevention and environmental health manager, shares screen for presentation.

Every year the State reviews Washington's shellfish growing areas. None of the areas in our County are being threatened with a downgrade in classification. You can see the sites online, highlighted green areas show approved growing areas. Water samples are analyzed, identify potential sources of pollution. Press release was made on April 29th confirming SJC shellfish growing areas meet Public Health Water quality standards. Local public health programs are a factor in maintaining high standards. Robust on-site septic operation and maintenance program. Shellfish safety program which regularly collects and analyzes samples.

Charles: what's the frequency of shellfish sampling? Especially during season changes

Jessica: less testing during off-season. I believe it's monthly

ACTION: Jessica will confirm timing and get back to Charles directly via email

• Report on Puget Sound Day on the Hill- Frances Robertson

This is hosted by Puget Sound Partnership (PSP) and NW Straits Commission (NWSC). Asking for support for some specific funds like SRFB and passing certain legislation like Floodplains recovery act. 60 people came from WA state; took part in 49 meetings with congressional officers from all over the country. Numerous federal departments, Transportation, Commerce. Met with Reps Larsen, Randall and Senator Murray.

PSP and NWSC organized an event with various congressional officers to come speak about the importance of restoration as a priority and that Puget Sound is an economic backbone to the State. Addressing the challenges of sea level rise, Congressman Larsen specifically called out SJC for work with derelict vessels.

This year was more optimistic than last year and our delegation came away more positive.

Tillery: I met with Frankie. We discussed the cutting of funding to scientific departments at the Federal Level

Frankie: I wasn't in the meetings with NOAA or EPA. There's a group called Environmental Protection Network hiring many former EPA employees and continuing some of their work,

We've lost so much institutional knowledge and expertise from the federal government

Lovel: Friends of SJ's participate in Puget Sound Day on the Hill as well, great opportunity to engage with folks working on similar issues. Garnered support for the ERTV. And need to remind delegation that protection is important and less costly ultimately than restoration.

Kim: buck up, those experts are still out there, we've been through this before

Olivia: thanks to Frankie and everyone representing our needs in DC. I'd love to get involved next year

- Report on April 29-30 SRFB Site Visits

One day in the field and one day virtual site visit presentations. Sam shares screen with excel spreadsheet Land Bank had two projects on Orcas that ended up being pulled – Judd Cove and an Eastsound acquisition for various reasons around funding/preparation. Four projects moving forward.

These four applications total request 1.3 million; allocation likely expected to be around 1.2 million. This year includes PSAR funding. Won't be sure about exact allocation until some other budget information is available. This includes money we borrowed last year from several other entities which we'll repay this year.

- SRFB Grant Round next steps

Still early in the process of reviewing proposals. MRC/CAG will do final evaluation based on 15% socioeconomic criteria in August and that will become part of SJC final scoring.

Charles: are MRC members meant to hold comments until August?

Sam: technically meant to score on socioeconomic but welcome to chime in on other aspects at this stage

Charles: regarding first project, some issues with the proposal.

Sam will report back in June!
